OVERVIEW

The Unykorn platform API provides programmatic access to all modules: investor onboarding, KYC/AML event feeds, transaction submission, registry queries, reporting extracts, and compliance document vault. The API follows REST conventions with JSON payloads, bearer token authentication, and standard rate limiting. Full API reference documentation is provided under NDA as part of the technical integration package.

Sandbox environment access is provided at the start of the technical integration phase. The sandbox mirrors production capabilities with test stablecoin values and synthetic ledger entries. Partners can simulate complete investor onboarding, subscription, distribution, and redemption workflows without affecting production data or custody balances.

Integration timeline for a standard Reg D program is 4-8 weeks from sandbox access to production readiness, assuming active engineering involvement on the partner side and timely completion of legal and compliance review. Custom chain integrations, novel token structures, or ATS connectivity add 2-6 weeks to the base timeline.

- 1 Execute technical services agreement and NDA for API access
- 2 Receive sandbox credentials and API key set
- 3 Complete API authentication and endpoint testing
- 4 Map partner workflows to platform API endpoints
- 5 Test investor onboarding, subscription, and distribution flows
- 6 Complete security review of API integration with partner IT
- 7 Obtain production API credentials and go-live clearance
